

West Irondequoit Central School District Optional Laptop Protection Plan

The West Irondequoit Central School District offers parents / guardians an optional laptop protection plan to help guard against accidental expenses due to damaged or stolen laptops.

1. **Protection of the Laptops:** Parents/guardians may choose to purchase the Laptop Protection Plan from the District to cover costs for repair and/or replacement in the event the laptop is accidentally damaged, destroyed, or stolen. The Laptop Protection Plan will remain in effect for the specified academic year. The plan will also cover the summer break period for students who are permitted to take their laptops home over summer break, concluding the third student day of the next academic year. Enrollment fees are adjusted for families who qualify for free/reduced lunch. There are no provisions for pro-rating of plan fees.
 - a. The plan covers costs for repair and/or replacement of a laptop due to accidental damage or theft after the payment of the appropriate deductible. The cost to enroll in the plan is a \$20 non-refundable fee for one school year.
 - b. If the laptop is accidentally damaged, the student or parent/guardian must pay a \$20 deductible. Coverage requires a written explanation from the parent/guardian. The District will pay for any further repair or replacement costs for a maximum of two incidents per plan year.
 - c. If the laptop is stolen, the student or parent/guardian must pay a \$50 deductible. The District will pay the remainder of the replacement cost. Police reports must be filed by the parent/guardian for stolen laptops. Copies of the police report must be provided to the District.
 - d. The Laptop Protection Plan does not cover damage or loss due to intentional misuse, abuse, gross negligence and/or criminal acts.
 - e. The Laptop Protection Plan does not cover loss of the device other than in cases of theft set forth above.
 - f. If parents/guardians do not enroll in the Laptop Protection Plan they are fully responsible for any repair or replacement costs up to a maximum of \$700 in the same way they would be responsible for any other damaged or lost school property such as textbooks.
2. **Protection Plan Summary**

Program Fees: *(Fees adjusted for those who qualify for free/reduced lunch)*

- Non-refundable enrollment fee- \$20
- Damage deductible- \$20 (each occurrence)
- Stolen deductible- \$50 (each occurrence)
- Power cords and carry bags are not included in the coverage.
- Liability limit- \$700
- Coverage: Repair or replacement of the school issued laptop for a maximum of two incidents per plan term.
- Refunds: No refunds after enrollment in the plan and delivery of the laptop.
- Pre-Existing Damage: The plan does not cover damage or loss incurred prior to enrollment in the program.

Coverage:

- ***Accidental Damage:*** Pays for accidental damage caused by liquid, spills, drops or other unintentional events (requires written explanation from parent/guardian)
- ***Theft:*** Pays for loss due to theft with a copy of a police report provided to the district.
- ***Fire:*** Pays for damage of the laptop due to fire with a copy of the fire report provided to the district.
- ***Electrical surge or natural disasters:*** Pays for the damage to the laptop for either with a written explanation from the parent/guardian.

Exclusions:

- Intentional misuse, abuse, gross negligence and/or criminal acts. This coverage will not pay if damage or loss occurs from the aforementioned exclusions. The parents/guardians will be responsible for the full amount of the repair/replacement.
- Consumables: Charging cable(s), AC adapter, carrying case and personal software.
- Cosmetic damage that does not affect the functionality of the device. This includes but is not limited to scratches or dents.
- “Jailbreaking” or otherwise voiding the manufacturer’s warranty by altering the hardware and/or software.
- West Irondequoit CSD is not liable for any loss, expense, or damage (including incidental, consequential or punitive damages) caused directly or indirectly by the equipment.
